Vendor booths are provided on a first come/first served basis. All forms must be received by July 24, 2019 to be included with initial advertising. We can take vendor applications up until August 1, 2019, but only if you have a valid insurance form. You are responsible for removing your own garbage. Quiet & non-noxious generators **only** are allowed if you need power. (No power is available, & area lights are low at night time for retail booths...bring lanterns!). If a booth is running a generator that is too loud, you will be asked to leave. **All food booths are required to obtain a Linn County temporary restaurant license. Contact Linn County Environmental Health; 541-967-3821.** No booth chairs, tables or shade/covers are provided; you must bring your own. Please be aware when bringing in your booths that the event location is in a pasture. You will need to bring in a vehicle that can handle a typical pasture; the area is also typically dusty.

Because our venue is growing, **we do not allow 'repeats' of food types.** We do allow variations in food, such as gourmet ice-cream vs. waffle cones vs. soft serve. (We try to separate these booths as much as possible). Food Vendors new to our venue should have a back-up food option if we already have a food vendor serving what you were planning to serve. Remember, first come/first served!

Vendors will once again be located in the middle of the event space. The space is located next to the large tent & beer garden area, directly behind the event tracks and bleachers. The event is bigger this year, and we've eliminated the pulls on Sunday, focusing on the big stuff happening on Friday night and Saturday. The stock and modified options will operate in the evenings, while amateurs will be pulling for only a couple of hours during the day.

Booth spaces vary, and can range from 10' x 10' up to 30' x 30' in size. Please specify the size of your booth area below:

#### Set Up:

You will be sent the vendor space number and a map prior to the event showing where you will be located. That will also show you which entrance you should be using when you arrive. On the day of arrival, you will check in with Michele Eldridge. You may set up as early as 12:00 pm on Friday, or 9:00 am on Saturday. All booths must be set up, and vehicles removed from the area by one (1) hour before the GA gates open. We will allow you to have one vehicle parked behind your booth. You will be allowed to drive your vehicle into the event area in order to off load your booth elements when setting up, and when breaking down, but we ask that you not drive through the event area when it is in operation. Ask for event staff for mid-day deliveries. If you have a motorhome and would like to stay onsite, please contact the City to arrange for reserving a RV space; your space as a Vendor is free of charge. However, please be aware that there are no hookups of any kind for RV's.

When you check in with Michele, you will purchase weekend event bracelets for yourself, and all staff members who will be on site. Family members do not get in free. All people working in a vendor booth **MUST** have a weekend event bracelet on. People at the event with no bracelets will be asked to leave by security.

Important Note for 2020: There are still no vendor fees this year, as we build our event back up after the 15 year hiatus. As this event becomes more successful, the booth fees will change in the future. All vendors who do business with us this year will be invited back in 2020.
